Because of our pain and the inexhaustible persistence of his grieving mom countless lives will be saved. Nothing can bring him back but knowing the young man that

stood up to bullies and embraced the kids who were excluded lives on through this legislation, brings some peace to our tragedy.

We have been fighting for this for so long. After Jake passed away, we knew we didn't want any other family to go through this pain. We knew we had to do something so we created the JEM Foundation to honor him and our first priority was what is now Jake's Law. Jake is more than his mental illness and he is more than his death. In a lot of ways this is Jake's legacy, forever immortalized and enshrined in Arizona law. He was full of compassion, empathy, and love, he always looked out for others. I know that this is what Jake would have wanted us to do. We can't bring Jake back but we can make sure this doesn't happen to other families. Thank you for allowing us to honor Jake.
